# San Luis Obispo County LCP Amendment LCP-3-SLO-24-0063-2 (Crye Redesignations, Cayucos)

Public hearing and potential action on request by San Luis Obispo County to change the land use designation of two parcels from Commercial Service (CS) to Residential Multi-Family (RMF) at 273 Birch Avenue and 250 Ash Avenue, and to add a new standard to allow a slightly increased structural height at 273 Birch Avenue, all to help facilitate increased residential development in the unincorporated community of Cayucos in San Luis Obispo County, and if the Commission does not take final action, possible action to extend the deadline for final Commission action on the amendment. # City of Laguna Beach LCP Amendment No. LCP-5-LGB-24-0026-1 (Housing Programs and Incentives)

Public hearing and action on the request by the City of Laguna Beach to amend the certified Land Use Plan (LUP) and Implementation Plan (IP) in accordance with State housing laws and the City's Housing Element. The proposed amendment would modify existing chapters of the City's Zoning Code, which is a component of the IP, and add new chapters related to density bonuses, single-room occupancy units, transitional and supportive housing, low barrier navigation centers, reasonable accommodations, home occupation/work-live standards, and lot consolidations for senior and affordable housing projects. Accordingly, the Local Business/Professional and Commercial/Tourist Corridor land use designations in the Land Use Element, which is a

component of the LUP, would be amended to maintain consistency with the proposed IP amendment, Laguna Beach, Orange County. (EG-LB)

# City of Dana Point LCP Amendment No. LCP-5-DPT-24-0033-1 (Victoria Boulevard Specific Plan)

Public hearing and action on the request by the City of Dana Point to modify the Land Use Map within the Land Use Element of the General Plan to amend the land use designation of "Community Facility" and "Recreation/Open Space"; creates a new land use designation of "Victoria Boulevard Specific Plan," makes changes to the zoning map by amending the zoning designation of "Community Facility" and "Recreation" and creating new zoning designation of "Victoria Boulevard Specific Plan" (both the Land Use Map and Zoning Map are components of the City of Dana Point Local Coastal Program (LCP), commonly known as the "1996" LCP); and establish the Victoria Boulevard Specific Plan, which would serve both as the Land Use Plan (LUP) and Implementation Plan (IP) for the property located at 26126 Victoria Boulevard, Dana Point, Orange County. Application by Surfside Colony, LTD to remove existing 84 ft. long, 6 ft. tall, unpermitted trex fence and install new approximately 78 ft. long, 3 ft. 6 in. tall post and cable fence on the beach along the Surfside Colony southern property line adjacent to Anderson St., Surfside - Seal Beach, Orange County. ### Application No. 1-22-0260 (Alexandre Dairy, Del Norte Co.)

Application of Alexandre Dairy to replace obsolete water diversion intake system on the Smith River to support ongoing agricultural uses on ~355 acres in surrounding floodplain (APN 103-020-074), including installing new screened intake structure to withdraw up to ~2,500 gallons per minute (reduced from previous ~8,000 gpm), new pumps, air compressor, cleaning system, panels, meters, and ~4,500 ft. of 18-inch-diameter underground irrigation lines trenched to a depth of 4 ft., located 15 miles north of Crescent City, Del Norte County.
